NEW HCFA FORM INFORMATION FOR 2019

We have received confirmation from Freedom/Optimum that there is a new protocol for proper HCC capture. The new procedure allows for capturing all HCC's including RX HCC's in a claim.

This should be implemented as soon as possible. Please communicate to your in house billers or billing company right away.

2019 HEDIS TIPS

It's not too early to start completing HEDIS measures on your patients. Ideally, this should begin with the patient's first visit of the year. Things to keep in mind are:

- COA's must be completed every year
- BMI must be completed every 2 years
- Make sure any recent hospital discharges are seen as soon as possible to comply with the MRP measure
- Become familiar with all the applicable Frailty and Advanced Illness exclusions. (For more information on these exclusions please refer to our last newsletter-4th quarter 2018)
- Encourage diabetic patients to schedule their DM eye exam when eligible
- Diabetic patients should be sent for HbA1c and DM Nephro labwork on their first visit of the year

TRANSITIONS OF CARE (TRC)

Proper transition of care from the inpatient setting is beneficial to monitoring a member's health. Communication lapses occur between inpatient and outpatient providers as well as between inpatient providers, the patient and/or their caregiver. Important information regarding medication changes, plan of care and follow-up appointment dates can be lost in the process. Transition of Care Measures include the following:

- Notification of Inpatient Admission.
- · Receipt of Discharge Information.
- Patient Engagement After Inpatient Discharge.
- Medication Reconciliation Post-Discharge.

It is imperative that all PCP's begin to properly bill ALL measures related to the Transitions of Care measure as indicated above. Your scorecards will now reflect TRC towards the bottom under display measures. This measure will *likely* be incorporated into your HEDIS scores next year for DOS 2020.
